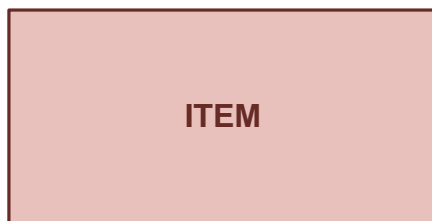


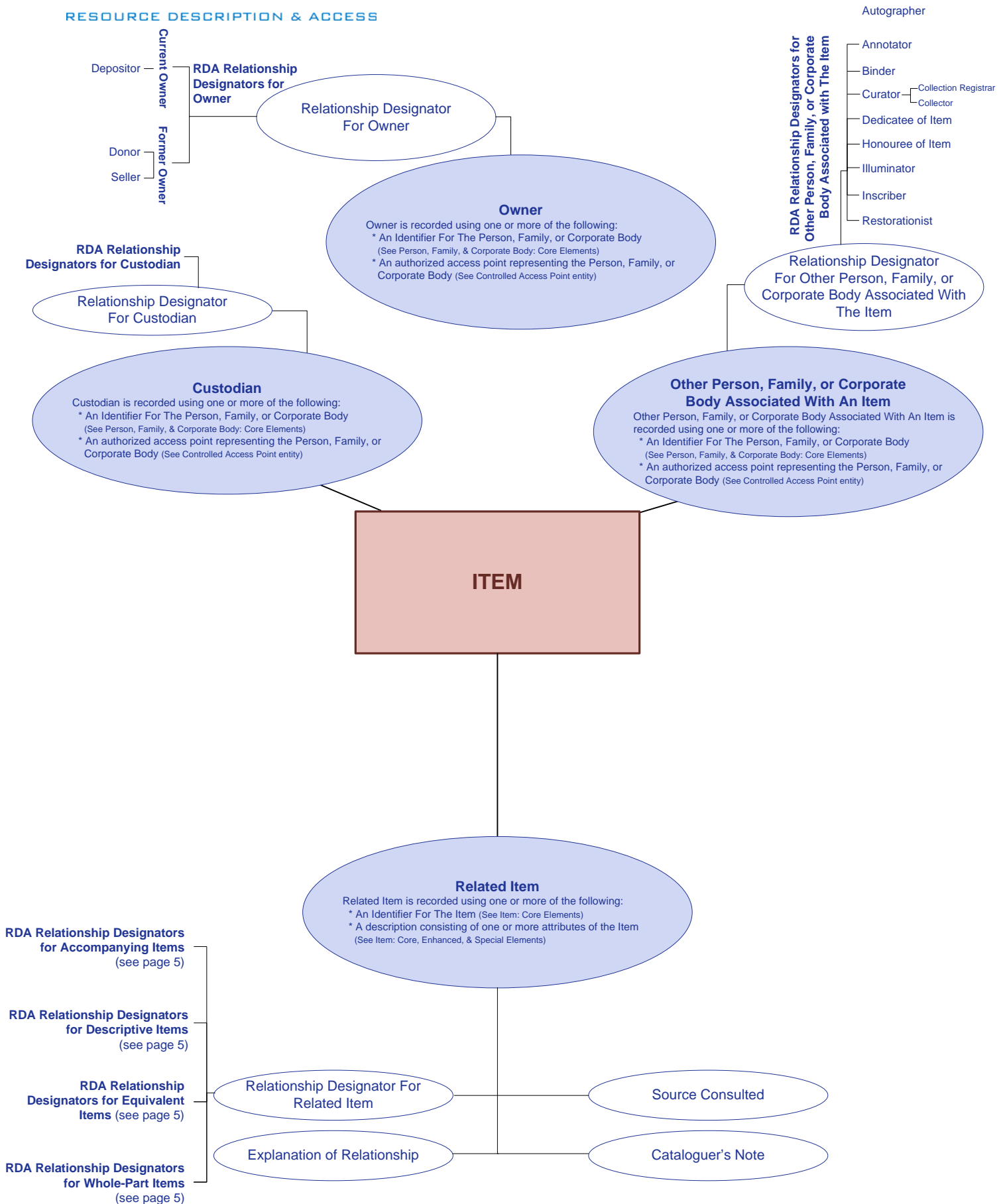
Manifestation Exemplified. The manifestation exemplified by an item.



Item Carries No Core Relationships

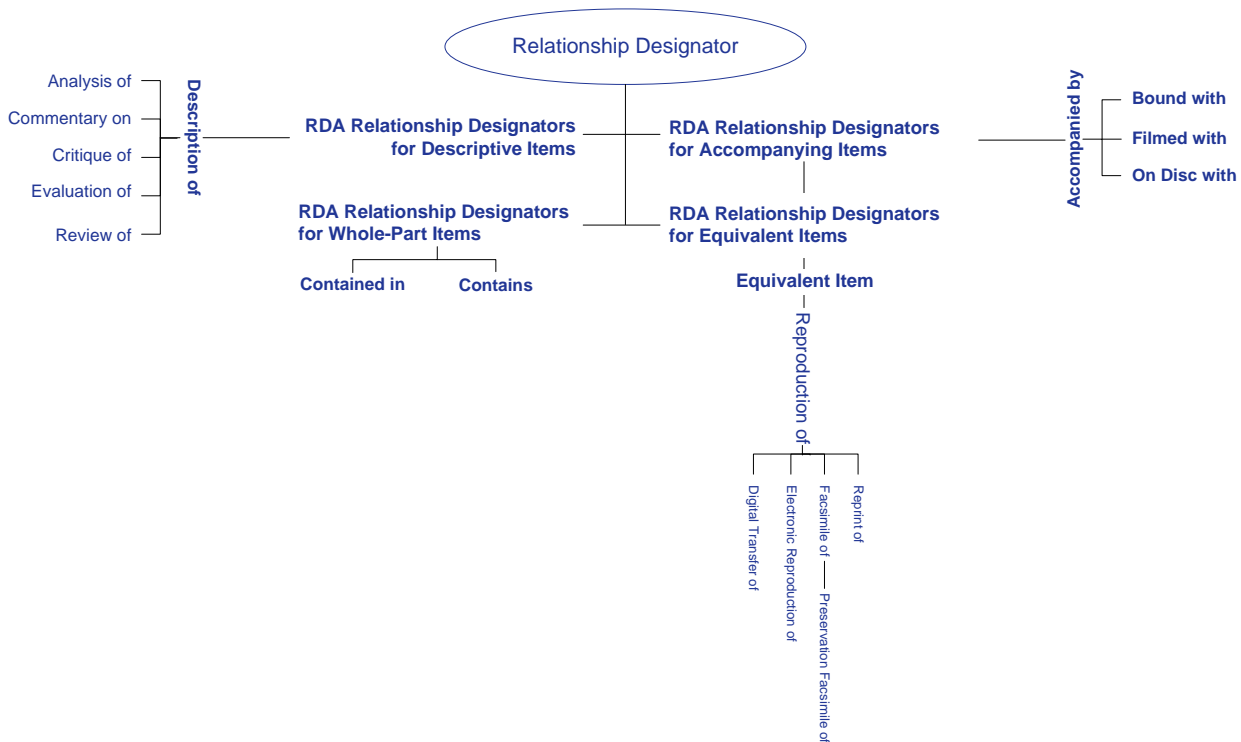

RESOURCE DESCRIPTION & ACCESS

Custodian. A person, family, or corporate body having legal custody of an item (i.e., a specific copy or instance of a resource).

RDA Relationship Designators for Custodian..

Other Person, Family, or Corporate Body Associated With The Item. A person, family, or corporate body **other than** an owner or custodian associated with an item.

Includes curators, binders, restorationists, etc.

RDA Relationship Designators for Other Person, Family, or Corporate Body Associated With The Item.

Autographer. A person whose manuscript signature appears on an item.

Annotator. A person who makes manuscript annotations on a specific item.

Binder. A person who binds a specific item.

Curator. A person, family, or corporate body conceiving, aggregating, and/or organizing an exhibition, collection, or other item.

Collection Registrar. A curator who lists or inventories the items in an aggregate work such as a collection of items or works.

Collector. A curator who brings together material from various sources that are then arranged, described, and cataloged as a collection.

Dedicatee of Item. A person, family, or corporate body to whom an item is dedicated.

Honouree of Item. A person, family, or corporate body honoured by an item, e.g., a person to whom a copy is presented.

Illuminator. A person providing decoration to a specific item using precious metals or color, often with elaborate designs and motifs.

Inscriber. A person whose manuscript notes appear on an item.

Restorationist. A person, family, or corporate body responsible for the set of technical, editorial and intellectual procedures aimed at compensating for the degradation of an artifact, such as bringing it back to a state as close as possible to its original condition.

Owner. A person, family, or corporate body having legal possession of an item (i.e., a specific copy or instance of a resource).

RDA Relationship Designators for Owner.

Current Owner. A person, family, or corporate body currently having legal possession of an item (i.e., a specific copy or instance of a resource).

Depositor. A current owner of an item who deposited the item into the custody of another person, family, or corporate body, while still retaining ownership.

Former Owner. A person, family, or corporate body formerly having legal possession of an item (i.e., a specific copy or instance of a resource).

Donor. A former owner of an item who donated that item to another owner.

Seller. A former owner of an item who sold that item to another owner.

Related Item. An item related to the resource being described (e.g., an item used as the basis for a microform reproduction).

RDA Relationship Designators Accompanying Items.

Accompanied by. An item brought together with another item, subsequent to issuance.

Bound with. An item that has been bound within the same binding as the item being described.

Filmed with. An item that is contained on the same microform with the item being described.

On Disc with. An item that is contained on the same disc with the item being described.

RDA Relationship Designators Descriptive Items.

Description of. An item described by a describing entity.

Analysis of. An item that has been examined to identify its components and their relations.

Commentary on. An item used as the basis for a set of explanatory or critical notes.

Critique of. An item used as the basis for a critical evaluation.

Evaluation of. An item that is examined or judged.

Review of. An item used as the basis for a summative evaluation.

RDA Relationship Designators Equivalent Items.

Equivalent Item. An item embodying the same expression of a work.

Reproduction of. A particular item used as the basis for a reproduction.

Digital Transfer of. An item transferred from one digital format to another.

Electronic Reproduction of. An analog item used as the basis for an electronic reproduction.

Facsimile of. A particular item used as the basis for an exact reproduction.

Preservation Facsimile of. An item used as the basis for an exact reproduction on preservation-quality media, such as acid-free permanent or archival paper.

Reprint of. An item that is used as the basis for a reprint with the same content as the resource being described.

RDA Relationship Designators Whole-Part Items.

Contained in. A larger item of which a part is a discrete component.

Contains. An item that is a discrete component of a larger item.

Explanation of Relationship. Information elaborating on or clarifying the relationship between an entity represented by a preferred access point and/or identifier and a related entity.

Source Consulted. A resource used in determining the name, title, or other identifying attributes of an entity, or in determining the relationship between entities.

Cataloguer's Note. An annotation that might be helpful to those using or revising the preferred access point representing an entity or relationship data, or creating a preferred access point representing a related entity.
