# ISBD punctuation

## AACR2

- Rules incorporate the ISBD specifications on the order of elements and on the punctuation that is to be included between areas and between elements of a given area

## RDA

- RDA is a content standard, not a display standard
- Instructions on the order of elements and on ISBD punctuation are not an integral part of the code but appear in Appendix D

# Title

## AACR2

- Per 1.0D2, the following elements are required when preparing a second-level description
  - Title proper
  - Parallel title
  - Other title information

## RDA

- Only Title proper is core
- Parallel title and Other title information are optional

  - Date of publication
- When these elements are not identified, other elements may be added (e.g., distributor's name, copyright date) if present; these elements are added but do not replace the core elements.

# Extent – Text

- Essentially the same as in AACR2
- Main differences
  - Description in terms of pages or leaves depending on whether the resource is paginated or foliated
  - No abbreviations (use *pages*, *volumes*)
  - No bracketing for unnumbered pages (use *unnumbered pages*)
  - No *ca.* (use *approximately*)
  - No *i.e.* (use *that is*)
  - Bibliographic volumes are not recorded, only physical volumes (*5 volumes*, not *8 volumes in 5*)

- Authorized access point
- Authorized access point for a work (i.e. preferred title + authorized access point for the creator, if appropriate)

# Access points

- Main entry: rule of three is abolished
- RDA doesn't impose a limit on the number of access points
- Creator is a core element; if there is more than one:
  - only the creator having principal responsibility named first in resources embodying the work or in reference sources is required
  - if principal responsibility is not indicated, only the first-named creator is required

# Creator

- RDA 19.2.1.1: Person, family, or corporate body responsible for the creation of a work. Creators include persons, families, or corporate bodies jointly responsible for the creation of a work.
- Corporate bodies are considered to be creators when the works that they are responsible for originating, issuing, or causing to be issued, fall into one or more of the following categories provided for at 19.2.1.1.1 (formerly 21.1B2)

# Bible

- Abbreviations “O.T.” and “N.T.” are no longer used for “Old Testament” and “New Testament”
- Books are entered as subheadings of “Bible” and not of the appropriate Testament

# Compilations by a single creator

- Conventional collective titles may be used if the compilation consists of 2 or more works (rather than 3 or more)
- For incomplete compilations
  - Access point for each of the works
  - Alternative: conventional collective title followed by “Selections” instead of (or in addition to) access points for the works
  - “Selections” replaced with “Works. Selections”

# Musical works

- RDA doesn't include instructions equivalent to AACR2 21.23C1 and 21.23D1 a) which allow compilations by various composers to be entered under a principal performer, even if his/her responsibility doesn't go beyond that of mere performance, execution, etc.

# Musical works

- Medium of performance no longer limited to 3 elements
- Terms “accompaniment”, “arranged” and “unaccompanied” are no longer abbreviated in access points
- Distinction between pre-twentieth century and post-nineteenth century works was removed for key

# MARC Format

- Changes to identify RDA records
  - New code “rda” established for use in 040 \$e in bibliographic and authority records
  - 040 \$e made repeatable in bibliographic and authority records
  - Leader/18 (Descriptive cataloging form) will be coded “i” (ISBD punctuation included) in bibliographic records
  - 008/10 (Descriptive cataloging rules) will be coded “z” (Other) in authority records

# Content, Media and Carrier Types in MARC Format

- Already indicated in MARC in fixed fields
  - Content type = Leader/06
  - Media type = 007/00
  - Carrier type = 007/01
- New fields were defined for RDA terms in bibliographic, authority and holdings formats
  - Content type = field 336 (bibliographic and authority)
  - Media type = field 337 (bibliographic and holdings)
  - Carrier type = field 338 (bibliographic and holdings)
- New fields may contain the RDA term (\$a) or a code (\$b)
- Subfield \$2 contains a code that identifies the source of the term or code, e.g. rdacontent, rdamedia, rdacarrier
