# Background

The April 2012 RDA update included a new element for Note on Expression and the revision of the element Note (in Chapters 2 and 3) to Note on Manifestation or Item. When making these changes to the RDA element sets in the Open Metadata Registry (OMR), I noted the following:

In the RDA Element Set in OMR, the "Note" element has been split into two bound properties: "Note (Manifestation)" which has the FRBR Manifestation as its domain, and "Note (Item)" which has the FRBR Item as its domain.

Because RDA treats these as a single element, I updated the label and definitions as follows:

# Note on Manifestation or Item (Manifestation)

An annotation providing additional information relating to manifestation or item attributes.

# Note on Manifestation or Item (Item)

An annotation providing additional information relating to manifestation or item attributes.

Because it makes sense to treat these as distinct elements in the Element Set, I would like to change the labels and definitions as follows:

# Note on Manifestation (Manifestation)

An annotation providing additional information relating to manifestation attributes.

# Note on Item (Item)

An annotation providing additional information relating to item attributes.

Following discussion, it was agreed that the element names and definitions would remain as updated in the Registry, and that I would present a proposal to make appropriate changes to the Registry, the Element Analysis tables, and the text of RDA.

This, belatedly, is that proposal.

# Changes to the RDA Element Analysis tables and the Registry

There are two issues here: (1) the label and definition for these elements, and (2) the status of the "element sub-types" included in both the Element Analysis tables and the Registry.

#### 1. Note on Manifestation or Item: labels and definitions

**Proposal 1A:** Define the following elements in the Registry:

#### Note on Manifestation (Manifestation)

An annotation providing additional information relating to manifestation attributes.

#### Note on Item (Item)

An annotation providing additional information relating to item attributes.

**Proposal 1B:** Include the following in the Element Analysis table:

Note on manifestation	element	manifestation	literal?	plain	n/a	n/a
Note on item	element	item	literal?	plain	n/a	n/a

Note that each of these elements appears twice in the table, based on their presence in both RDA Chapter 2 and Chapter 3. As noted below, there is a different list of sub-types in each chapter. *Question:* Is this duplication justified? Should these be consolidated?

#### 2. Note on Manifestation or Item: element sub-types

The following sub-types are currently defined for Note on Manifestation or Item in chapter 2 (all of these have manifestation as their domain):

*Question:* It is clear that these represent distinct sets of RDA instructions, but it is not equally clear that there is any advantage to treating them as formal element sub-types. Should these be retained in the element set or deleted?

If the sub-types are retained and the Chapter 2 and Chapter 3 elements are consolidated, the resulting elements would be:

Note that neither option deals with the issue of the appearance of these two elements in two RDA chapters. There are two possible solutions to this: (a) merging the two sets of instructions for Note on Manifestation and Note on Item; and (b) creating separate elements for the two note elements in Chapter 2 and the two note elements in Chapter 3. Neither solution is terribly attractive. It is not clear that the appearance of an element in two chapters within RDA is a problem that needs to be solved, and therefore no solution is recommended here.

# Changes to the Text of RDA

The following is a rather minimal editorial proposal for revising RDA to separate Note on Manifestation from Note on Item in Chapters 2 and 3. In order for the instruction numbers to make sense, I chose to use Option 2 above; this does not constitute a recommendation, but is merely the simpler numbering.

In the event, most of the current instructions apply specifically to either manifestations or items. Therefore, the proposal, for the most part, includes only section headings, with a note indicating that no change to the text is required. Because the changes are minimal, I have used standard mark-up, but have not included a clean copy.

The exercise raised a question concerning "missing" instructions and examples. The current instructions in Chapter 2 for specific categories (2.20.2–2.20.13) **all** deal explicitly with notes on manifestations; there are **no** instructions or examples dealing with notes on items. The proposed instructions for Note on Item, therefore, consist solely of very generic instructions based on 2.20.1. This section really needs to be developed further with appropriate examples. Almost any category of note that applies to a manifestation might also apply to an item. At the very least, some examples should be added to the new 2.21.1.3. My brief was to propose editorial changes,
