The text below reflects the decisions made by the Joint Steering Committee during its November 2013 meeting and in email discussion after the meeting. Other changes in 0.6.4 and 8.3 are from 6JSC/BL/12/rev/Sec final and from 6JSC/BL/13/Sec final. The first and third changes in E.1.2.4 are from 6SC/BL/12/rev/Sec final.

# 0.6.4 Section 3: Recording Attributes of Person, Family, and Corporate Body

## 9.3.1.1 Scope

A date associated with the person ▼ is a significant date associated with the history of a person (e.g., date of birth, date of death).

#### 10.4.1.1 Scope

A date associated with the family ▼ is a significant date associated with the history of a family.

## 11.4.1.1 Scope

A date associated with the corporate body ▼ is a significant date associated with the history of a corporate body, such as date of establishment, date of termination, or its period of activity. For a conference, it is the date or range of dates on which a conference, etc., was held.

#### 11.4.1.3 General Guidelines

[ $1^{st}$  paragraph and its list unchanged except for addition of  $4^{th}$  line below in the list]

period of activity (see 11.4.5).

[2<sup>nd</sup> and 3<sup>rd</sup> paragraphs unchanged]

Record a date associated with a corporate body by giving the year or range of years.

If the year can only be approximated, record the date in the form *approximately* [year].

Record a period of activity expressed as a range of years in the form [year]-[year].

Record a period of activity expressed as a range of centuries in the form [century]-[century].

## 11.4.2.3 Recording Date of Conference, Etc.

Record the year or years in which the conference, etc., was held by applying the basic instructions at 11.4.1. Record a range of two or more years in the form [year]—[year].

# 11.4.5 Period of Activity of the Corporate Body CORE ELEMENT

Period of activity of the corporate body is a core element when needed to distinguish a corporate body from another corporate body with the same name.

# 11.4.5.1 Scope

Period of activity of the corporate body is a date or range of dates indicative of the period in which a corporate body was active.

## 11.4.5.2 Sources of Information

Take information on period of activity of the corporate body from any source.

#### 11.4.5.3 Recording Period of Activity of the Corporate Body

If a corporate body's date of establishment and date of termination are both unknown, record a date or range of dates indicative of the corporate body's period of activity. Apply the basic instructions on recording dates associated with corporate bodies at 11.4.1.

**EXAMPLE** 

1810-1818

approximately 1700

If it is not possible to establish specific years of activity, record the century or centuries in which the corporate body was active.

**EXAMPLE** 

19th century

16th century-17th century

# 11.13.1.5 Date Associated with the Body

Add a date or dates associated with the body (see 11.4.3–11.4.5) if needed to distinguish one access point from another when the following elements are not available:

place (see 11.13.1.3) associated institution (see 11.13.1.4).

# Glossary:

## **Date Associated with the Corporate Body**

A significant date associated with the history of a corporate body, such as date of establishment, date of termination, or its period of activity. For a conference, it is the date or range of dates on which a conference, etc., was held.

# **Date Associated with the Family**

A significant date associated with the history of a family.

#### **Date Associated with the Person**

A significant date associated with the history of a person (e.g., date of birth, date of death).

# **Period of Activity of the Corporate Body**

A date or range of dates indicative of the period in which a corporate body was active.
