11.7 Other Designation Associated with the Corporate Body CORE ELEMENT

Type of corporate body is a core element for a body with a name that does not convey the idea of a corporate body. For other corporate bodies, other designation associated with the corporate body is a core element when needed to distinguish a corporate body from another corporate body with the same name.

11.7.1.3 Recording Other Designations Associated with Corporate Bodies

Record other designations associated with the corporate body by applying these instructions, as applicable:

type of corporate body (see 11.7.1.4) type of jurisdiction (see 11.7.1.5) other designation (see 11.7.1.6).

Record the type of corporate body in a language preferred by the agency creating the data. If there is no equivalent term for the type of corporate body in a language preferred by the agency, or in case of doubt, record the type of corporate body in the official language of the corporate body.
