

## Where Did It Go?

This document contains a **partial** list of elements and instructions that have changed from the current Toolkit to the beta Toolkit. Because the content in the beta Toolkit is a work in progress there may be further changes to elements listed here. The information reflects the content of the beta Toolkit as of June 18, 2018.

Elements in the column for the beta Toolkit are listed using the entity name followed by the element name. Other instructions are given according to their location in the beta Toolkit. Other designation (11.7.1.6)	Deprecated; <i>see</i> instructions in Corporate Body: authorized access point for corporate body	covered by changes to instructions for access points

Creator (19.2)	Work: creator of work	renamed to avoid confusion with new element
Other Agent Associated with Work (19.3)	Deprecated; <i>see</i> Agent: related agent of work	not needed because of changes to elements

Contributor (20.2)	Expression: creator of expression	LRM treatment of aggregates
