
Miriam Björkhem, Head of Metadata and National Bibliography Unit, National Library of Sweden, welcomed everyone to our host library and told about the history of the library.

2. Chair report

EURIG has 53 member institutions, with a good level of engagement. This is shown not only by the presence and contribution of all attending here, but also in the 8 new representatives we have since last year as member institutions keep EURIG in mind when there are staff changes.

So, Welcome all and in particular to the new faces 'at the table'.



EURIG exists to promote the interests of current and potential users of RDA in Europe, and to provide a forum for discussion and co-operation, where we can communicate and benefit from each others' experiences. We are also charged with the dissemination of information from the RSC, and to contribute to the development of RDA by working with the RSC.

As well as putting together the content for our annual meeting, and keeping the membership list up to date, the EURIG Executive committee have improved the website, thanks in large part to Hannes Lowagie.

Since our last meeting we have also followed up on the vote that took place to choose a new logo, and that is now in place.

On the meetings page you will find links to past presentations, and in due course the presentations from this meeting too. It is a useful source of inspiration and information which I recommend to you all.

As more of us make the move from original RDA to the official RDA, and bearing in mind there's now an end date for original RDA being available, which is May 2027, the sharing of good practice and resources will continue to be vital. The Executive hope that sharing of Application Profiles will be beneficial, and we've mocked up a Webpage to show you what that could be.

Bearing in mind that external documents cannot ignore RDA copyright by unfairly copying large parts of the Toolkit, any organisation wanting to share their AP must honor the RDA permissions policy and respect the copyright. We hope that many EURIG members will see this as beneficial and share their APs. A show of hands approved this plan.

I want to repeat that EURIG exists to promote the interests of current and potential users of RDA in Europe, and to provide a forum for discussion and co-operation, where we can communicate and benefit from each others' experiences. If you have any ideas of ways in which EURIG could help its members more, the Executive Committee would love to hear from you

A principal task of the Executive is to make sure we have an annual meeting. I'm delighted to report that a member institution has offered to host us next year, and that is the Royal Library of Belgium, so I look forward to seeing you in Brussels next year.

I'm not completely finished with my duties as Chair, but the final Chair Report at the end of my 2 year tenure seems the best place to thank you, and especially my colleagues on the Executive committee – you've made my job very easy. Huge thanks also to Liv and Katerina and their team for hosting us here at the National Library of Sweden, it is much appreciated.

Jenny Wright gave a report, as she also has a place at the RDA Board, as copyright holder representative.

She informed that the board is working on getting a new strategic plan in place. This is due next year.

She also encouraged EURIG members to get in touch with their representatives if they have any suggestions for the Board, as it is there to serve the users of RDA.

5. News from the RSC

Renate Behrens, Chair RDA Steering Committee, and James Hennelly, Director, ALA Digital Reference, shared news from the RDA Steering Committee.

6. Executive Committee – office bearers

With great thanks to Jenny Wright for her service, EURIG members were invited to stand as new Chair, the post being due for election.

Luna Sindin Cordery, Biblioteca de Catalunya representative, volunteered to be Chair and was elected unopposed.

7. Update on UNIMARC (remote presentation)

Florence Tfibel provided an update on UNIMARC development with respect to RDA, on behalf of the Permanent UNIMARC Committee.

8. Report from the European BIBFRAME Workshop 2024

Matias Frosterus reported on the activities of the Bibframe Workshop in Europe.

9. Group discussion on Al

The delegates were divided into groups and held discussions in separate rooms, guided by a list of prompt questions (see Appendix 6). Upon reconvening, a spokesperson from each group shared the key points from their discussions.

There was a widespread interest in the potential of AI in cataloguing, particularly in enhancing metadata, improving workflows, and increasing accessibility of resources. Participants mentioned the potential of AI in assisting cataloguers by identifying inconsistencies in bibliographical records, suggesting additional fields in records, and aiding with ISBD punctuation.

Several concrete AI initiatives currently in place were highlighted. For example, tools have been developed to assist cataloguers in selecting classifications, subjects, or related authorities. Additionally, projects aimed at improving older data with AI were mentioned, such as matching duplicate records and adding language codes to records based on transcribed metadata in M21 fields like 245.

However, concerns regarding AI were also raised:

<u>Legal concerns:</u> There are questions about whether AI will respect copyright and comply with GDPR, for instance regarding the inclusion of author information in authority records.

Environmental concerns: The use of AI should be judicious and not applied indiscriminately.

<u>Quality concerns:</u> Reliable data is paramount, but the basis for AI-generated metadata can often be unclear, leading to potentially inaccurate, illegal or problematic results. Data provenance was mentioned as a key point here.

<u>Employment concerns:</u> Although AI can improve workflows, there is apprehension that it may pose a threat to certain jobs within the library sector.

<u>Language Concerns:</u> The effectiveness of AI may vary significantly depending on the language community involved.

In summary, while there is recognition of the potential benefits of AI, there is also a clear understanding of the need to manage expectations carefully.

Proposals – 2024/2025


- Proposal to Revise Name of Corporate Body
 - Prepared by the Religious WG. Discussed and approved at the November 2024 meeting. Allows recording official name of corporate body even when publications use a different name
 - Religions WG was given specific permission to go beyond the limits of their mandate and identify broader areas in the Toolkit where their proposal would apply.
- Proposal to add glossary definitions for fictitious entity and non-human entity
 - Prepared by Technical Team Liaison Officer and Examples Editor. Discussed at the November 2024 meeting and approved with changes to wording. Request to include "exhibiting human characteristics" to definition of non-human entity not approved.

RDA as a Cataloguing standard

- RDA was always intended as a cataloguing standard. It comes from the Anglo-American tradition and the Original Toolkit has largely continued this tradition.
- But cataloguing was already in a phase of upheaval at this time.
- This process has been intensified in the following years and all standards, not just RDA, must face up to the new challenges.

RDA since 2015

- The committees responsible for RDA took up this challenge back in 2015, and the 3R project marked the start of a paradigm shift for cataloguing with RDA, some of which is still ongoing.
- This has changed a lot for the user communities, which does not always seem easy at first, but offers new opportunities for many.
- The circle of user communities has thus been significantly expanded and numerous applications in the field of cultural institutions have been created since then.

It focuses on exploring UNIMARC's range of uses, increasing familiarity with its entity-relationship (ER) cataloguing track, and gathering information about the library community's needs.



UNIMARC in the world




- · 69 full answers, from 18 countries
- Almost always from a national library/bibliographic agency
- From different types of users: direct users (for cataloguing or exchange), users of UNIMARC-based formats, or of other formats keeping updated.



To change or not to change, and why?



- Need to replace their ILS (technically obsolete, financial reasons, integration into a network) (7)
- Wish to adopt a new ER content standard or format (5)

User expressed needs

Better and more user-friendly documentation online (manuals, information about UNIMARC ER)

Tutorials, especially on how to migrate from classic UNIMARC to UNIMARC ER

Compliance with RDA, with frequent updates

A Strategy ("roadmap") for entity-based cataloguing with UNIMARC

➤ (Re)evaluate long-term strategy for UNIMARC within IFLA metadata standards

- Review of survey and 6th UNIMARC Users Meeting
- Review of ISBD-UNIMARC Harmonization Group Report to the PUC
- SWOT analysis of UNIMARC development
 - · Strengths, Weaknesses (internal factors)


Modern MARC

- Library of Congress' set of guidelines for producing MARC records that are easier for BIBFRAME
 - · Aims to better comply with RDA
- https://www.loc.gov/marc/ModernMARC-index.html
- Less coded data in fixed fields
 - · Favors strings and identifiers
- More identifiers
- · Minimal ISBD punctuation

BIBFRAME 2.4

- · Relations between entities from direct to indirect
 - This removes "hardcoding" from these relations and allows easier interoperability with, e.g., RDA relations
