Subject: Proposal to Revise Name of Corporate Body

The text below sets out decisions taken by the RSC in their meeting in November 2024.

RSC/ReligionsWG/2024/2 and its responses were <u>published on the RSC website</u> and <u>with stable</u> <u>URI in the institutional repository</u>. Its discussion is recorded as Item 487 in <u>RSC/Minutes/483-</u> <u>499</u>, where weight was given to the statement in <u>RSC/ReligionsWG/2024/2/NARDAC</u> <u>response</u>: "We do not understand why the condition option to use an official name offered with Recommendation 1 would not apply to any case where there are different forms of name for the same corporate body. We do not understand why it would apply only in cases where no value of a name is predominant or formally presented. All the preceding conditions/options could also involve a name that is not a real or official name and therefore require another option to choose the real or official name."

Although I was tasked to prepare and implement RSC/ReligionsWG/2024/2/Decisions (<u>RSC/Minutes/483-499</u> Item 487.4), the Chair was also tasked with communicating to the Chair of the Religions in RDA Working Group that they are empowered to move their suggested instructions to a broader area of the Toolkit, as suggested by NARDAC (<u>RSC/Minutes/483-499</u> Item 487.1). A draft of RSC/ReligionsWG/2024/2/Decisions has, therefore, been circulated to the Chair of the Religions in RDA Working Group, with the request to consider whether the instructions could be placed in a broader part of the Toolkit.
